Subject: Complaint Regarding Mental and Emotional Harassment of My Son and Denial of Parental Access

Respected Sir/Madam,

I, **Vivek Manohar Mengji**, currently residing at **C-306, R9, Oro Avenue, Life Republic by Kolte Patil Township, Marunji, Pimpri-Chinchwad, Maharashtra 411057**, wish to bring to your immediate attention the severe mental and emotional harassment faced by my 4-year-old son, **Adhiraj Vivek Mengji**, at the hands of my estranged wife **Apurva Vivek Mengji (daughter of Mr. Atul Shalgar - +91-9422035001)** and her family.

My estranged wife, **Apurva (+91-8007308088)**, has been residing with our son at her parental house located at **House Number 55, Rangole Colony, Shahupuri, Satara, Maharashtra 415002**, for the past year. Without any legal court order or pending cases, I have been unlawfully denied access to meet or spend time with my son.

Details of the Incident:

1. On my personal visit with my parents to my in-laws' residence four days ago (**on 27-11-2024**), I was allowed to meet my son for only 15 minutes. During this brief meeting, my son **Adhiraj** emotionally confided in me about the trauma and fear he is experiencing in their care. He cried and pleaded to come with me.
2. My son has expressed that he is living under extreme fear, particularly due to the behavior of my mother-in-law.
3. My in-laws and wife have threatened me with false allegations and misuse of laws, creating further mental agony for both me and my son.

Key Concerns:

- The mental and emotional well-being of my son **Adhiraj** is at serious risk due to the toxic environment in which he is being raised.
- The unlawful denial of a father's right to access his child is causing significant emotional damage to both me and my son.

- The threats of false cases from my in-laws are intimidating and obstructing my ability to take necessary steps for my son's safety.

Immediate Requests:

1. **Conduct a thorough investigation into the conditions under which my son is being raised, including his daily activities, routine, and mental and emotional health.**
2. Ensure the safety and well-being of my son by protecting him from any potential harm or trauma caused by my estranged wife and her family.
3. Provide immediate and transparent intervention to enforce **my parental rights and allow equal parenting access, as emphasized by the Hon'ble Supreme Court of India in its judgments on equal parenting.**
4. Take appropriate legal action against my wife and her family for unlawful actions and for creating an environment of fear and abuse for my son.

I place my trust and hope in the **Maharashtra Chief Minister, Home Minister, Indian Judiciary, and Law Enforcement Agencies to prioritize the welfare, health, and future of my son, Adhiraj Vivek Mengji, who deserves a safe, nurturing, and loving environment.**

I earnestly request you to take urgent action to address this matter and uphold the rights and well-being of my son.
