

## Request Information

I am writing to bring to your kind attention the severe hardship my family and I am facing due to the discontinuation of my electricity supply by the TN&E/EN&C Board (TN&E) over the past year, we have been living without electricity, which has caused immense difficulties in our daily lives.

TN&E has imposed a substantial penalty of \$11,354 on my household and has taken away my electricity needs. Despite my repeated attempts to resolve the issue with the concerned authorities, there has been no relief. I am currently preparing for the Civil Service Commission, and the absence of electricity has severely impacted my studies. Additionally, I have children who are now struggling without proper lighting and other basic necessities.

I would also like to inform you that I should have applied for my payments, but I do not have enough to complete a proof of payments. Due to this, I am facing further

president@india.gov.in) Subject: Urgent Appeal for Justice and Electricity Reconnection for My Family - Child Suffering Due to Over One Year of Power Cut (Rajapuram Substation), With utmost pain and hope, I, Rajeshwar, a citizen of India from Thirukkamangalam village, Thiruvaremur district, Tamil Nadu, humbly write this appeal to seek your kind intervention. My family, including my innocent child, has been suffering without electricity for more than a year, and all my efforts for justice have been ignored by the local electricity department. My

child's service connection (No: 000001 0000) was discontinued in May 2022, but the electricity meter was reconnected only in November 2023. We were never asked to pay a penalty of ₹10,000. I have already submitted multiple petitions, including to the CM Cell (Petition No: TN.EnergyTVA@PWRCL.COM/2023/11/13/266) and 2000, but no real action has been taken.

On 21/06/2023, the District Collector of Thiruvaremur kindly issued oral instructions to restore our electricity connection immediately and to accept the penalty in their local offices considering our poor condition and our child's health. But sadly, the TANGEDCO officials are ignoring the collector's order, and further demanding full payment of ₹10,000. A new service connection fee of ₹5,000 and a No Objection Certificate (NOC) from temple authorities as our house stands on temple land -- but they are refusing to issue it. We are helpless. My child is falling sick due to heat and mosquito bites, and we are living in darkness. We are being pushed from door to

door like criminals, with no money, no justice. We are emotionally broken and mentally tortured. I have knelt on every difficult day. Now, I turn to you, our country's highest Constitutional authority I plead with folded hands -- please save us. Kindly direct the Tamil Nadu Electricity Board and local authorities to either reconnect or provide a new service connection without further harassment, and waive the penalty if accepted in installments as per the collector's direction. I am ready to obey all reasonable conditions. I only ask for justice, light, and dignity for my family and child. Additionally, we are facing another injustice - we are being denied a No Objection Certificate (NOC) by the local temple authorities regarding the land where our house stands. Despite repeated written enquiries, they refuse to issue the NOC, and we are unable to proceed further. We are now trapped with no power, no justice, and no support. Even after approaching various grievance portals, no department has truly heard our cry. I am ready to pay the penalty of ₹15,000 in installments, but no one offers a solution. This is a direct violation of child rights, health rights, and basic human dignity. I humbly request your kind and swift interventions to instruct the concerned authorities to either reconnect the electricity service or provide a new connection with necessary permissions, especially when a Collector himself has supported us. Please save my daughter. Please save our family. You are our last and only hope.
