IN THE COURT OF HON^{BLE} PJ CJ CUM XI ADDL. METROPALITAN MAGISTRATE, KUKATPALLY, CYBERABAD. Honored Sir, Today i.e On 19.05.2025 at about 1900 hours, received a petition from Sunkar Shiva Kumar S/o Sunkar Manaiiah, age 37 yrs, Occ: Private Employee, R/o. Flat No 301, Sai Balaji Compex, Kailash Hills. Cell No: 8464890623. Which read as follows. The brief facts of the case are that on 18.05.2025 at about 1335 hours, the complainant's wife Deepthi Kolluri contacted him via phone call and asked him to come home and take their baby, since he had been previously blocked on Whatsapp and was denied access to her child, he considered this a genuine opportunity to meet and care for his child upon reaching their residence at Praneeth Antilia Villa No 541 and picking up his baby lovingly, his father in law Prasad Babu Kolluru who was under the influence of alcohol suddenly without provocation started beating him mercilerly using his hands and later started beating him with iron rod, soon after his wife and mother in law locked the main door and joined his father in law in beat him hands and rods and took his car keys and belongings, and also they used abusive filthy language and threatened and he kept asking them why they were assaulting him, but they continued their physical aggression showing rods, he called 100 police and explained the situation to police. In December 2024, his wife created repeated disturbances at her home and subjected him to severe mental cruelty, and on 17th April 2025 he managed to convince his wife to let him celebrate his son's birthday, yet post celebration they all participated in birthday and once again refused to allow the child to return the home with him, as such now he came to PS and lodged a petition against 1) Prasad Babu Kolluru, 2) Radha Krishnaveni Kolluru, 3) Deepthi Kolluri, 4) Nalini Bala Babu, 5) Shivaji Bala Babu to take necessary action as per law.
