Subject- I am Priyanka Chaudhary would like to draw in faouver of my 9 years old daughter your esteemed attention to an extremely distressing and momentous matter against Mr. G. Karthikeyen, S/o P. Ganesan, under section 63 of Bhartiya Nyay Sahita, 2023 and under section 5 of POSCO Act 2012.

1. That I, Priyanka Chaudhary, aged 30 years, mother and legal guardian of Havisha (9 years old), wish to file an immediate serious complaint against G. Karthikeyan, S/o P. Ganesan, residing at 404 Asiad Village, South Delhi.
2. That, Since September 2023, G. Karthikeyan has subjected me to cruelty and rape under false pretences of marriage promises. Moreover, starting from December 10, 2024, after he took me back to my own residence, he has repeatedly sexually assaulted my minor 9 daughter, Havisha.
3. That, On Night of 10 December 2024, he stayed at my residence and administered sleep-inducing drugs to me. While I was sleeping, he sexually assaulted my daughter. When she tried to protest, he told her, "Beta - mummy is sleeping, so don't make noise. I won't hurt you." causing her to become silent out of fear and trauma. Due to this trauma, she did not disclose the incidents immediately the next day, but it became a normal occurrence whenever he visited my house.
4. That He has molested my daughter multiple times starting from December 2024 to 1 July 2025, sometimes asking her to sit on his lap, sometimes putting fingers in her private parts, and at other times



attempting to ask her to hold and rub his private parts. As a result, my daughter has become extremely distressed, with declining academic performance and increased silence. He threatened her, saying, "I am saving your mother from others, cooperate or I will kill your mother, or give her poison."

5. Since May 4, 2025, during a visit to my home, he subjected her to further abuse in the kitchen. He gave her condoms and attempted to explain their use while I was bathing, which caused her great distress and fear. Despite her trauma, she did not disclose what happened earlier because of ongoing threats and her fear of his visits.
6. In June 28 2025,( night) and 29 June 2025 he forcefully stayed at my house again, during which he severely assaulted me and also harmed my daughter. He inappropriately rubbed his private parts against her and took her to another bathroom of my house, asking her to hold and lick his private parts. He threatened her harshly, warning that if she shared these details, he would give her mother an injection that would cause her immediate death.
7. That Between July 3 and July 13, 2025, while suddenly absconded and stopped visiting my house, during his absence for a week, I had a serious altercation with him on the last day seeing that, my daughter finally mustered courage to speak about his abusive acts he was doing with her. On the evening of July 13, 2025, my daughter confided in me about the abuse in detail. Filled with guilt and remorse, I immediately filed complaints and tried to confront him at his residence. However, he locked his door, fled, wherein I called the police, ( PCR)
8. That Despite my persistent efforts to contact him, On July 14, 2025, he refused to speak to me, avoided confrontation, and involved the

police to evade accountability by fabricating false stories of the relationship using his influences and power.

9. That I humbly request your immediate action on this grave matter to ensure justice and the safety of my minor daughter.

### **PRAYER:**

Therefore, it is humbly prayed before the concerned Police Officer and Station Head Officer kindly look into the matter and provide justice. There are people in our society who misuse their power and influence to manipulate officials and hide their true nature. But the truth about who they really are must come to light. No one should be allowed to harm our innocent daughters and walk away protected by their status or reputation. I placed my trust in him, believing in his promises of marriage, and his seniority ( 55 year old individual) — but behind closed doors, he was hurting my little minor girl. All I want now is justice for my daughter to sleep peacefully being as her mother. Let the truth be revealed — not just for my child, but for every child from such individuals. That is kind only prayer.
