

Karnataka police inactive role to deal with Minor girl mental harassment case

Case details

FIR number 0311/2025/Rajanukunte PS, Doddaballapura sub -Di, Date of FIR 03/11/2025.

My kid is studying in the above school from 2024 June to till date. She joined in 4th Class and then promoted to 5th Class in 2025 June month. In 2024, We have submitted medical reports to the School to take care of the as she has mild ADHD ([attention deficit hyperactivity disorder](#)). It is clear that If kid is provoked, she will be out of control emotionally and physically. The school is well aware of it. We have also offered shadow teacher to monitor kid in the school. But the school denied shadow teacher in the month of Jan or Feb in ~~2024~~ 2025. We have also submitted medical reports in the month of 2024 June to the school informing Kid need special attention. School promised special care multiple times.

Incident details

From the month of August 2025, my kid has been tortured physically and mentally. She has been slapped by School principal multiple times. My kid has been isolated in a separate room from August 2nd week without supervision for many days.

We also observed, Ira, our kid has not eaten lunch box. She was not taken care.

Ira's mother has been called by school multiple times, but the isolation in a separate room has never been told to us by verbally or by writing. I also met Principal on 20th sept, but Principal has never revealed Child has been punished with Isolation.

Ira has been taken away from class for many months, she has been discriminated many months, She has not been taught for many months. School never informed about the punishment she has been receiving for months. School only called to complain about Kid, (reaction to the punishment). With the ~~school~~ harsh behaviour and the biased treatment, Ira has been clearly provoked both mentally and physically. Ira has learnt

bad/abusive/aggressive language to defend herself and started pushing teachers to defend herself. All her uncontrollable behaviour has been learnt from School. All the bad behaviour reported by school does not have any evidence or witness. A minor can be easily framed to trigger aggressive behaviour by school, It is commonsense. I am claiming this aggressive behaviour and abusive language is learnt from school to defend herself in the school. We have noticed her odd behaviour at home post August.

Ira was removed from dance classes from August, She was targeted. She was targeted by her class teacher and principal. Out of 8 students only Ira has been removed from Dance classes and dance event on 15th August 2025. She has been slapped by Principal between 11th/12th August for questioning, "Why she was not part of Dance event"

An eye witness says the child has been isolated from august 11th onwards, they had isolated her from her own friends and classmates and schoolmates.

We have reported all above incidents to Mamata, Director of the school on her phone number 9845414260 on 25th Oct.

Mamata has not investigated the incident properly and reported all false facts. Mamata told Ira has been Isolated from 3rd Oct, But Ira has not gone to school on 3rd Oct. It is clear she is not interested to investigate the matter seriously. Principal told on the first incident on 24th Oct, Ira has been isolated for last 10 days, And she has confirmed she can only provide 10 days CCTV footage. Later Principal with Mamata, Direcor changed voice and confirmed Ira has been isolated from 3rd Oct (Which is also a false statement).

Parties involved in the crime

Mamata, Director of the school, who has not taken any action on the complaint and misled the parents.

Roopa Laxmi, Principal , who is main person in the crime to Isolate kid and slapping kid.

Roopa Darshini, Class teacher for targeting kid and stopping kid to pursue class, removing from the class and Isolating child.

Preeti Gour: LKG or UKG class teacher and our neighbour for spreading rumours to principal.

Each party role

Mamata, Director of the school has not done the job of investigation and given all false statements in the Zoom call on 28th Oct 6PM with Principal and all other class teachers. Mamata has only false information. Mamata has not responded to our calls and postponed meeting requests many times, as minimum as 5 times. Mamata gathered all false information from school without any evidence, to protect school commercial interest.

We have asked school to provide CCTV footage from August 15th. But the CCTV footage has been edited, we were shown only edited and in adequate footage. CCTV footage was not available from 15th August.

we had requested cctv footage from august 15th till 24th oct but CCTV footage was made available between sep 9th to 24th October.

Footage also partial and edited. From 15th August to 9th Sep, CCTV footage has been destroyed. From 19th Sept to 2nd Oct, School holidays. Sep19th onwards till Oct 24th CCTV partial is available. Ira was found some days with and without observation of sub staff.

Ira claiming Sub Staff Geetha was rude. Sub Staff Geetha rude behaviour is observed in CCTV footage.

2nd party

Roopa Dharshini is the Ira, 5th class teacher and Maths teacher, who has been behind these incidents. She shouted, discriminated, threatened, Isolated, Bullied, removed Ira from class, and Spread roomers to the other class teachers. Roopa Dharshini also influenced Pallavi, Kannada teacher to turn against Ira.

3rd Party

Principal holds same responsibility of Roopa Dharshini, Principal has done more crimes than class teacher, hiding facts, Hiding Isolation, hiding facts, Hiding evidences, and physical abuse she has done to Ira. Principal also instructed staff to destroy evidence and edit the CCTV footage. Principal slapped Ira multiple times.

Between 11th August to 12th August, Principal slapped Ira, Principal pulled Ira from Dance practice session in the Assembly area to 4th Class, locked and then slapped. Ira disturbed dance class because she was removed from 15th Aug Dance event.

4th Party

Preeti gaur is the LKG class teacher working in Same school, she is living in Godrej avenues apartment, she is in our same community. We also live in Godrej Avenues apartment. She was once Ira Monther friend, but she has been kept at a distance by Ira's mother due to personal reasons. Preeti Gaur has a major role to spread rumours in the school against Ira and her mother. Preeti Gaur has spread rumours to Roopa Darshini, (class teacher) and the principal at the school and we have the witness while she was spreading ill about Ira's mother.

Caste discrimination by principal and Class teacher

School asked parents to submit Caste certificate in the month of July. Ira's mother submitted Caste certificate in the month of July, From August 1st and 2nd Week onwards the discrimination started in the school. Ira and her mother Pushpa Jayaram were targeted on caste bias. Only post caste certificate submitted in the school, the principal and the class teacher wild behaviour is seen. From June 2024 to July 2025, Ira has been good in the school, post caste certificate submitted, the discrimination has been started.

Why a private school asking for Caste certificate of 5th Class student. This is a clear basic rights violation. School has no right to ask for Caste certificate unless otherwise, Students or parents claim for support from Government. We are paying fee for our kid more than

My demand for fair investigation of the entire incidents from Indian government

I request Karnatak police commissioner to receive CCTV footage from 1st August from the school for all 57 cameras, CCTV footage has clear evidence of Ira being isolated for months and the rude behaviour of sub staff towards child. It is the evidence, I also submit ZOOM call we had with School director, where she confirmed, School has isolated kid from 3rd Oct 2025 (Which also false statement). Zoom call evidence is enough to investigate this matter further.

Please seize school immediately until investigation is over. Please submit this case to Judicial department to suspend management and seize the school until investigation completed. This is not a civil case, criminal and minor child Racial abuse case, School has already taken many excuses to destroy evidences and editing evidences. Please investigate the matter immediately.

Please suspend Director, Principal and teachers mentioned in the email. Director and Principal are threatening staff, if information is shared with Parents. Director and principal also destroyed and destroying evidence.

Investigae entire incidents with Teachers, Sub staff, and Ira class mates (5th Class).

Also investigate Ira, although she is not much expressive.

Please collect each day, 5th, class room footage, Language room and Kriya room footage.

Other 4 witness and evidence will be provided to the court of law in the due course.

Please collect CCTV footage, 4TH class room, Between 11th August to 12th August, Principal slapped Ira, Principal pulled Ira from Dance practice session in the Assembly area to 4th Class, locked and then slapped. Ira disturbed dance class because she was removed from 15th Aug Dance event.

I request Karnataka police to use all your professional tools and expert tools to investigate this matter like the routine criminal investigation you do.

Damage done to minor child

Mental harassment, Physical abuse, caste bias, discrimination based on caste, and many more crimes listed down.

my child is now going to a behavioural modifications therapy for to gain back her Low self-esteem, Trust issue, Chronic anxiety, Difficulty forming relationships ,School dropout ,Long-term emotional and behavioural disorders .

My child has undergone unnecessary mental and physical suffering, public humiliation, abusive languages, constant criticism , discrimination and deliberate isolation , humiliating treatment by teachers, neglect of emotional support , due to all these she has developed behavioural changes like withdrawal , aggression, fearfulness, clinginess , academic issues like drop in grades, lack of focus, absenteeism emotional distress like sadness, anxiety, guilt, irritability , social isolation like avoiding friends or teachers.

she has undergone three months of constant punishment in front of her classmates by the teachers, abuse, and unpleasant events

My kid IRA has been Discriminated, Physically abused, Emotional and verbally abused, neglected and bullied

Following are the legal crimes committed by school and staff

- **Physical punishment:** The RTE Act of 2009 explicitly prohibits all forms of physical punishment in schools for children aged 6-14.
- **Mental harassment:** The National Commission for Protection of Child Rights (NCPCR) guidelines also prohibit mental harassment.
- **Discrimination:** Discrimination based on gender, caste, class, or disability is also forbidden.
- **Physical Abuse:** This involves inflicting physical injury on a child by non-accidental means, such as beating with a PVC pipe or belt, causing bruises, burns, or disfigurement. Corporal punishment is explicitly banned by law and any form of physical discipline by school staff is considered an offense.
- **Emotional/Verbal Abuse:** This can involve a pattern of actions like verbal humiliation, making violent threats, refusing to acknowledge a child's presence, and creating mental harassment. Such abuse is recognized as a form of maltreatment that can have severe psychological effects.
- **Neglect:** In a school context, this involves a failure to provide for a child's basic needs or proper supervision, such as failing to provide necessary medical attention or leaving children unsupervised.

- **Bullying:** Both peer-to-peer and staff-to-peer bullying and harassment are forms of violence that are addressed in policies and guidelines to ensure a safe learning environment.
