

I, Samanwita Kar, was sexually abused by my 10 year elder brother, during my age 3 — 15. The abuse included forced oral, insertion of a fountain pen, a thin candle etc till my Class IV along with non-penetrative humping. After my Class IV, when I refused to be alone with him at home, I was groped by him, multiple times a day, throughout the day till my Class 10. My parents used to be also beaten badly by my brother and offered me no protection. Over the years, my brother started to completely deny ever having done anything to me and my parents forced me to keep a normal relationship with my brother. I had no option other than recording calls between my parents and me, where they discussed the abuse at great length, along with saying they didn't have an option to protect me since they were also being beaten by their son. In 2017, my brother threatened to get me killed, via political connections and I filed a complaint (not an FIR as my mother requested me not to affect his life or visa). A copy of that complaint was sent to him, to dissuade him from any such plans.

In 2023, I decided to proceed legally against my brother and filed a complaint with honourable National Council for women under the complaint number C230020593, after years of him denying ever having done anything to me, calling me a seasoned prostitute etc. At that time, my parents got to know about me having the call records and over further recorded calls, begged me to not affect their son's third marriage, and also told me my father had just one year to live, and their grandson (my brother's son) was too little to be without a father, if my sibling goes to jail.

I withdrew my complaint under constant manipulation and crying from them. Due to them denying the abuse, I had started to write on Quora without mentioning my brother's name since 2014-15. The Quora profile also served as a warning or hope to countless families where such an abuser is already being created under similar circumstances. However, over the years, I have been repeatedly coerced to delete Quora, citing "it's all in the past". I have several call records explicitly mentioning the abuse, in my parent's voice. I have witnesses from school, who I had confided in, when I was a small child. Due to constant threats from my sibling regarding filing a defamation suit against me, my parents ended up giving me a written statement, to safeguard myself, if my brother filed such a suit, after they died. Even in 2023, my parents had accepted the sexual abuse happening, and how they feel it is all in the past and should not be discussed or remembered any further. I demanded an apology from my sibling, which was denied, citing "it can be used as proof later". They requested me to let my brother escape the Indian judiciary, take citizenship in Canada and not proceed against him legally. I agreed with the same; but my parents still kept relentlessly harassing me. In 2025, I left India after relentless harassment by my parents to keep contact with me, even after years of their betrayal. I have been under mental health treatment since 2011, and I am under medications and therapy to this day.

My parents have brought in financial and property related allegations against me, despite having clear emails, call records which substantiates none of that is true. My parents even went on to tell me over recorded calls that they were giving false evidence to their son, post 2023, after knowing I had call records from the past, and they had, on record, claimed they would tell any lie against me, in order to save their son. I was told that they would never

harass me again, but the same has not been followed. I have been relentlessly harassed, coerced, threatened, cornered and isolated. It is pertinent to mention that I have never earned any money from this social media. I have realized that no matter how much I try to forgive, perpetrators of violent crime will continue to threaten the victim. I was told my brother was this reformed man but the same does not appear to be true. As of now, I wish to re-open my complaint that was filed in 2023 (C230020593 with NCW), if not feasible, file a fresh complaint who can conduct a fair investigation of the evidences I have supporting each and every word of my claim of the sexual abuse.
