Subject: Complaint regarding physical, mental, and emotional abuse of my minor son Sanjeev

It is respectfully submitted that the minor child is frequently left at the residence of **Ms. Hema Madhunika**, a family acquaintance of the child's mother, until late night hours, often **up to 11:00 PM**, without adequate parental supervision.

During such occasions, the child has been subjected to **mental and emotional harassment, humiliation, and verbal abuse** by Ms. Hema Madhunika. The child has expressed feelings of fear, distress, and emotional discomfort while staying at her residence.

Further, the son of Ms. Hema Madhunika has **disclosed private family matters of the child to classmates at school**, including statements that the child is dependent on their family for food and shelter. These disclosures have caused the child **severe embarrassment, shame, social isolation, and emotional trauma** within the school environment.

Such acts have **seriously affected the dignity, self-esteem, and mental well-being of the minor child** and have created a hostile and unsafe emotional environment, both at home and in school. Leaving the child in the care of a non-guardian under such circumstances constitutes **neglect and emotional abuse** and is not in the best interest of the child.

It is submitted that the child's mother is a habitual alcohol consumer. During such periods, her behavior becomes aggressive, violent, and uncontrollable, directly endangering the physical and mental safety of the child.

I respectfully bring to the notice of the Hon'ble Committee that my elder son had also suffered burn injuries at the age of around three years while under the care of his mother, which indicates a recurring and dangerous pattern of negligence and abuse.

Recent Incident:

On **11.01.2026**, my minor son contacted me in a state of extreme distress after being **forcibly evicted from his residence by his mother**. Upon receiving this information, I immediately approached the **All Women Police Station, Hosur**, seeking assistance for the protection of my child.

During the interaction at the police station, my son **clearly and consistently expressed fear**, emotional distress, and his **refusal to return to his mother's custody**, citing concerns for his safety and well-being. His statements were spontaneous and made without any influence or prompting from my side.

Considering the child's ongoing **annual examinations**, and at the request and advice of the police officials, the child was **temporarily persuaded to continue staying in the same environment until completion of his exams**, with the understanding that the situation would be reviewed thereafter.

However, I respectfully submit that my **apprehension regarding the safety and mental well-being of my child continues to remain serious and immediate**, as the circumstances that led to his distress persist. The child continues to be under **fear, pressure, and intimidation**, and his emotional condition indicates that he does not feel safe or secure in the present arrangement.

Relief Sought:

I humbly request the Hon'ble Committee to:


- Take immediate cognizance of this complaint.
- Register the matter and order a detailed inquiry through a Child Welfare Officer.
- Ensure immediate safety and protection of the minor child.
- Order psychological counseling and mental health assessment of the child.
- Assess the caregiving fitness of the mother, particularly in light of alcohol abuse and violent behavior.
- Restrict third-party interference by non-guardians.
- Pass appropriate interim protective orders regarding custody, residence, and interaction.
- Respectfully request the Hon'ble Committee to issue an official Child Welfare Committee report after due inquiry, in order to safeguard the welfare of the minor child.

This complaint is submitted solely in the best interest, safety, and welfare of my minor child.
