

APPLICATION FOR IMMEDIATE PROTECTION & CNCP STATUS

To: The Chairperson/Bench of the Child Welfare Committee, New Delhi

Date: 26th December 2025

Subject: Formal petition for status as a Child in Need of Care and Protection (CNCP) due to physical assault, mental cruelty, and systemic neglect.

1. IDENTITY OF THE PETITIONER

I, Aman Mitra, aged 15, residing in Vasant Kunj, New Delhi, submit this statement voluntarily. I am currently an aspiring student of Computer Science and AI Ethics. I am seeking the immediate intervention of this Committee as my fundamental right to life and safety is being violated.

2. GROUNDS FOR IMMEDIATE INTERVENTION (JJ ACT SEC 75 & 82)

-> My home environment has transitioned from neglectful to life-threatening. I base this on the following factual matrix:

-> Physical Assault & Extreme Violence (Feb 2025): I was subjected to a sustained one-hour physical assault by my father. I was swung by the neck (strangulation), slapped repeatedly, and threatened with immediate eviction. My email to the NCPCR dated Feb 15th serves as a contemporaneous record of this trauma.

-> The October Escalation (Oct 8 – Oct 26): A severe crisis period where neglect turned into psychological warfare. I have documented a Cycle of Abuse involving gaslighting, triangulation (isolating me from my mother), and physical intimidation.

-> Caste-Based Abuse & Verbal Cruelty: I have documented evidence of my father using frequent caste slurs against me, constituting severe mental cruelty and a violation of my dignity.

-> Domestic Intimidation: My father's violence extends to my mother (e.g., the July 2025 incident of damaging property in a rage), creating a pervasive "Atmosphere of Fear."

3. EVIDENCE OF "SYSTEMIC FAILURE"

I have attempted to seek help through formal channels, all of which failed to protect me, leaving the CWC as my final recourse:

-> Childline (Oct 10): Contacted for help; no intervention followed.

-> NCPCR (Feb 15 & Oct): Two explicit emails sent regarding the danger of escalation and eviction.

-> School Intervention (Oct 14): A written request was submitted to my school for temporary shelter and CWC contact. I was met with cold dismissiveness and discouraged from seeking further help.

4. CLINICAL & PHYSIOLOGICAL IMPACT

The abuse is no longer just "mental"; it is manifesting biologically. I am suffering from:

-> Acute Physiological Distress: Frequent panic attacks and severe, recurring headaches.

-> Cognitive Impact: Notable "Brain Fog" and mental exhaustion.

-> Observed Inwardness: My class teacher has formally noted my state of "distress and inwardness," mischaracterizing it as introversion (Photo of observation attached).

5. THE SOVEREIGN DEMAND

I am not a "rebellious minor"; I am a victim of Narcissistic Abuse and physical violence seeking my legal right to a safe environment. I request the Committee to:

-> Declare me a CNCP immediately based on the failure of my guardians.

-> Provide Safe Shelter in a neutral location where I can continue my studies.

-> Order a Supervised Recovery of my essential items (Academic materials, IDs, and my Digital Archive).

-> Initiate Legal Action under Section 75 of the JJ Act for the cruelty endured.

ATTACHED EVIDENCE LOG (FOR IMMEDIATE REVIEW):

-> [Contemporaneous Record]: Sent emails to NCPCR dated Feb 15, 2025, and Oct 2025. These serve as a timestamped "Cry for Help" that went unanswered.

-> [Witness Statement]: Academic record and teacher observation documenting physiological decline.

-> [Digital Forensic]: Incident Index (Oct 8-26) documenting the cycle of Narcissistic Abuse and the threat of physical escalation. Evidence folder containing voice recordings, corroborative evidences and photos of violence.

-> [Educational Potential & Academic Resilience]: Despite the domestic instability, I have demonstrated a high-level commitment to my career in AI and Computer Science. I am submitting my Outskill Workshop Certificate, which I earned through 18 hours of continuous, intensive study over a 2-day period. This is evidence of my intellectual discipline and my potential to contribute to the field of AI Ethics and Development. My parents' environment does not support this growth; it actively sabotages it through "Brain Fog" and physiological distress.

URGENCY NOTE: Due to the "Cycle of Abuse" (sudden happiness followed by sudden attacks), my current "safe" periods are an illusion. I am in a state of constant hyper-vigilance. I request that my status be decided based on the documented pattern, not on the temporary "calm" the parents may attempt to project during a CWC visit.
